# Wildfires 2025 Selection Process Information for Players







## WILDFIRES 2025 SELECTION PROCESS (PLAYERS)

#### **NEW PLAYER SELECTION PROCESS**

Our 'Player Invite' model aims to:

- Create a greater level of visibility for potential players over a longer period under real playing conditions that maximises their chances to be 'seen' by selectors.
- Expose a greater number of players (32 instead of 23 only), to representative level coaching and development increasing a player's chance to be selected for Country/State championship teams.
- Reward players for their contribution and commitment to rugby

#### **STEP 1: NOMINATION PERIOD**

#### **PLAYERS**

All players may submit a 'Nomination for Consideration'

- This will be collected via Jotform over the nomination period and include:
  - Terms and conditions
  - o Name
  - o D.O.B
  - o Club
  - Current Team

#### PLAYER ELIGIBILITY NOTES

- If a player does not prioritise Rugby ahead of competing sports (i.e. asking for dispensation to play other sports), then the nominating player/squad member may not be prioritised by Wildfires Rugby and risk forfeiting their position to another suitable participant
- Lodging false dispensation forms is a serious offence and constitutes 'Nonattendance' of training and/or games, thereby impacting the minimum attendance rule
  - A player will receive a written warning if it is found they have breached this dispensation rule





- A second infringement will result in an immediate expulsion from the Wildfires Program
- Rigorous screening for "Coaches Considerations" must be passed by majority vote of the Wildfires Sub-committee with final approval by way of the HJRU bylaws
- Red Cards within the current season for a 'Breach of the Code of Conduct' or, 'Player Misconduct' may preclude inclusion in Squads, or as a 'Coaches Consideration' player.
  - Whilst not possible to provide a definitive and exhaustive list of inappropriate behaviours, acts of violence, intimidation and other forms of abuse will not be tolerated and is in no case acceptable.
    - Any player bringing the game into disrepute through misconduct or a breach of the Code of Conduct, will be required to show cause for consideration.
- Mandatory attendance of Wildfires 2025-Squad Training over the Summer period

#### STEP 2: CLUB COACH ASSESSMENTS

Each club coach will be sent a list of nominating players from their respective age groups with an attached information form including:

- Player commitment level (i.e. club participation level)
- Perceived ability to perform at representative level
- Coachability
- Communication skills etc

#### **COACHES NOMINATIONS**

Club coaching staff may also have the opportunity to submit a "Coaches Consideration" nomination on behalf of a player they believe may be a good fit for Wildfires Development Squads.

 Nominations from club coaches on behalf of a player will be restricted to 5 players maximum (outside of self-nominating players)

#### STEP 3: PLAYER OBSERVATION

With a list of player assessments coming from club coaches through communication and collaboration, selectors/coaching staff can also observe players they may need to consider during the regular season.





#### STEP 5: PLAYER/SQUAD ANNOUNCEMENTS

As not to disrupt the regular season and take the focus and attention of players during finals series games, Wildfire Squads will not be named until after the completion of Grand Finals on the 14<sup>th</sup> September, 2024.

#### **EXPECTED PLAYER LEVIES**

If a player is selected into a HJRU Wildfires Squad for 2025, the following player levies will apply:

- Proposed player fees/levies for Wildfires 2025 Squads will be as follows:
  - u12 u18s will be set at a maximum \$450 per season
    - \$150 is payable upon player acceptance and due by 30<sup>th</sup>
       September
    - \$150 is payable due by 8<sup>th</sup> December 2024
    - Remaining (Up to \$150) is payable <u>only by final team members</u>, due by 11<sup>th</sup> May, 2025
      - Squad members not achieving selection in the final team will not be required to pay any further levy amount regardless of whether they have been called into the final team at a later date due to injury, illness etc of another player.
  - Development teams will see an increase from \$220 to \$300
    - o \$150 is payable upon player acceptance
    - o \$150 is payable due by 11<sup>th</sup> May, 2025
